**FISCAL ANALYSIS**

**ASSUMPTION**

Officials at the **St. Louis County Board of Election Commission** assume with any one being able to vote by absentee ballot it would increase the volume of that type of voting substantially. For a county wide election this would likely increase our cost in the area by \$32,000 per election.

Officials at the **Platte County Board of Election Commission** assume that if half of the county's registered voters would choose to vote absentee, it would cost approximately \$65,000.

Officials at the **Office of the Secretary of State, Lincoln County, Buchanan County, and Callaway County** each assume no fiscal impact from this proposal to their respective organizations.

**Oversight** assumes the number of additional individuals that qualify under this proposal would be minimal, therefore the local election authorities could cover any costs by using existing resources.

Officials at the following board of election commissions: Kansas City Board of Election Commission, St. Louis City Board of Election Commission, Clay County Board of Election Commission, and Jackson County Board of Election Commission did not respond to **Oversight's** request for fiscal impact.
