FISCAL ANALYSIS

ASSUMPTION

Officials of the **Department of Natural Resources** assumes no fiscal impact.

Officials of the **City of Raytown** assumes there could be some minimal savings. Officials estimate savings at \$1,000 annually.

Oversight assumes this proposal expands the current nuisance abatement law to include vacant buildings, and would have no fiscal impact to state or local governments.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This bill expands the nuisance abatement law to include the abatement of vacant buildings or structures open to entry or other nuisances. The bill applies to all cities and villages and to Cass, Clay, Jackson, Platte, St. Charles, and St. Louis counties.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
