FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This proposal restricts the members of the governing council of the St Louis Special School District to two two-year terms. Members who have served for four or more years cannot serve again until at least three other members of the board of education of their school district have served as governing council members or until a total of six years have been served by other members of their board of education. Members in office who no longer qualify must be replaced within 30 days of the effective date of the proposal.

The proposal also provides that governing council members must report the substance of each council meeting to their respective boards of education at the next meeting, and minutes of governing council meetings must be provided to all member boards of education. Notice of governing council meetings must be posted at local district offices.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
