FISCAL IMPACT - Small Business

This proposal could fiscally impact small business vehicle body repair shops as insurance companies would no longer be allowed to contract with them for the performance of repair work.

DESCRIPTION

This proposal prohibits auto insurers from acquiring an ownership interest in an auto body repair shop. Any insurer that already has an ownership interest must divest itself of that ownership by 2006. The proposal also prohibits an auto insurer from compensating any person for referring an insured to an auto body repair shop owned by the insurer. Violation is an unlawful merchandising practice.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
