ASSUMPTION

Officials of the **Department of Elementary and Secondary Education** assume no fiscal impact.

Officials of the **Office of Secretary of State** did not respond. Oversight assumes there is no requirement for rule making, and the election is at the local level. Therefore, Oversight assumes no fiscal impact to the Office of Secretary of State.

Officials of the **St. Louis School District** assume there would be no fiscal impact.

St. Louis City Board of Election Commission did not respond.

Oversight assumes this proposal requires no additional elections to be held. Therefore, Oversight assumes no fiscal impact.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This act provides that the two St. Louis City school board members whose terms expire in April 2010 shall continue to serve until November 2010 when their successors are elected. Thereafter, the election date for those two members shall be the general election date in November, rather than the municipal election date in April.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
