**FISCAL ANALYSIS**

**ASSUMPTION**

Officials from the **Department of Revenue** assume the proposal would have no fiscal impact on their agency.

Officials from the **Office of State Courts Administrator** assume the proposed legislation would have no fiscal impact on the courts.

Officials from the **Department of Labor and Industrial Relations (DOLIR)** assume the proposal exempts misdemeanors in Chapters 301 (registration and licensing of motor vehicles) and 390 (motor carriers and express companies) from Crime Victims' Compensation Fund judgments. Currently, judgments for crime victims' compensation payments are not made for these two areas. Therefore, DOLIR assumes there would be no impact on the Crime Victims' Compensation Fund.

DESCRIPTION


Currently, in addition to the \$7.50 surcharge assessed on criminal court proceedings for the Crime Victims' Compensation Fund, the court must enter a judgment of \$10 for each plea or finding of guilt for a misdemeanor.

The proposed legislation would exempt from the judgments any misdemeanor convictions involving motor carrier regulation, pursuant to Chapter 390, RSMo, or motor vehicle licensing and registration, pursuant to Chapter 301.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
