**FISCAL ANALYSIS**

ASSUMPTION

Officials from the **Office of the Governor, Office of Administration – Administrative Hearing Commission**, and the **Department of Labor and Industrial Relations** assume the proposal would have no fiscal impact on their agencies.

Officials from the **Office of the Attorney General (AGO)** assume a relatively small number of cases the AGO handles in federal or state court would be impacted by this legislation. To the extent the AGO does have cases that are impacted, AGO assumes any additional costs incurred in discovery or pursuant to special hearings on whether the privilege may be divested can be absorbed within existing resources.

Officials from the **Office of State Courts Administrator** assume the proposed legislation would have no fiscal impact on the courts.
