ASSUMPTION

Officials from the **Office of Administration, Administrative Hearing Commission, Division of Budget and Planning, and Division of Personnel, the Department of Conservation, and the Department of Transportation** assume this proposal would have no fiscal impact on their organizations.

Officials from the **Department of Labor and Industrial Relations** assume this proposal would restate current practice with respect to employee discharges for certain job-related misconduct issues. Since claimants are currently subject to this disqualification there would be no difference in claims paid. Therefore, the proposal would have no fiscal impact to their organization.

FISCAL DESCRIPTION


The proposed legislation appears to have no fiscal impact.
