ASSUMPTION

Officials from the **Office of State Courts Administrator** assume the proposed legislation would have no fiscal impact on the courts.

Officials from Various Cities did not respond to Oversight's request for fiscal impact.

Oversight assumes the proposal is permissive, allowing the judge to assess court costs. The proposal is also dependent upon the defendant consenting to pay and having the ability to pay the costs. Therefore, Oversight has reflected no fiscal impact for the court costs.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.


