FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of State Courts Administrator** and **Department of Insurance, Financial Institutions, and Professional Registration** assume the proposal would have no fiscal impact on their agencies.

Officials from the **Office of Attorney General** assume any potential costs arising from this proposal can be absorbed with existing resources.

Officials from the **Office of Secretary of State (SOS)** state the fiscal impact for this proposal is less than \$2,500. The SOS does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the SOS can sustain within its core budget. Therefore, the SOS reserves the right to request funding for the costs of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the Governor.

Officials from the **Department of Insurance, Financial Institutions, and Professional Registration (DIFP)** believe the work required under the bill and the on-line real-time web based application can be completed within current appropriation; however if the costs are greater than anticipated, the DIFP would request additional appropriation through the budget process.

The DIFP would need to set up a RFP to establish the on-line application to monitor statewide compliance. One outside vendor charges 46 cents per transaction and the department is unsure if it can find a vendor to run the program for 10 cents per transaction. If that is the case, the department may need to request additional ITSD FTE and appropriation through the budget process.

The proposal will impact small business payday loan companies.


FISCAL DESCRIPTION
