**ASSUMPTION**

Officials from the **Department of Transportation, Department of Insurance, Financial Institutions and Professional Registration, Office of Administration, Missouri Western University, Northwest Missouri State University, Metropolitan Community College, City of Kansas City, University of Central Missouri, Missouri State University, and Linn State Technical College** assume that there is no fiscal impact from this proposal.

**Section 233.280**

**Oversight** assumes this proposal authorizes commissioners of road districts, upon majority vote, to provide compensation for their services of up to \$100 per month plus all expenses incurred in transacting business of the district. Oversight assumes this proposal is permissive and, by itself, would have no state or local fiscal impact.


