ASSUMPTION

Officials from the **Department of Transportation (MoDOT)** assume the fiscal impact to MoDOT would be the cost of the study, assuming they hired an outside engineering firm to do the report.

Oversight assumes this could be accomplished by MoDOT personnel however if they determine the study should be done by outside personnel the cost of the study would be accomplished during the normal budgetary process. Therefore, Oversight assumes the initial administrative impact of this proposal is \$0.
