ASSUMPTION

Officials from the **Administrative Hearing Commission** stated this proposal would have no fiscal impact on their agency.

House Amendment 1

In the House Committee Substitute (4267-05), the **Department of Elementary and Secondary Education** indicated costs associated with §168.1032.8 and **Oversight** assumed savings associated with the repeal of a portion of §163.172. House Amendment 1 removed both of those sections from the bill, therefore **Oversight** assumes, for fiscal note purposes only, no fiscal impact.

School districts did not respond to the previous version of this proposal. Due to time constraints, no responses have been received from school districts regarding the Perfected version of this bill.

FISCAL DESCRIPTION


The proposed legislation appears to have no fiscal impact.
