## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Public Safety - Missouri Highway Patrol, Office of the State Public Defender**, and the **Office of the State Courts Administrator** each assume the proposal would not fiscally impact their respective agencies.

In response to a similar proposal from this year (SB 646), officials from **Office of Prosecution Services** assumed no measurable fiscal impact from the proposal.

Officials from the **Department of Corrections (DOC)** state passage of this proposal may aid in arrests and convictions, therefore increasing the number of offenders sentenced to the DOC; however, there is no way to estimate the effect, either before or after passage. DOC assumes the fiscal impact of the proposal to their agency is either zero, or a minimal amount that can be absorbed by their agency each year.
