FISCAL ANALYSIS

ASSUMPTION

Officials at the **Office of Administration** assume the Division of Personnel would need to promulgate rules and regulations necessary to carry out these provisions.

Officials at the **Department of Conservation** assume an unknown fiscal impact because it is uncertain how many bids would actually attract bids from qualifies veteran-owned businesses and whether or not the five point preference would allow the award to go to a qualified veteran-owned business and whether or not that preference would actually increase the amount awarded.

Officials at the **Missouri Department of Transportation** assume there is no fiscal impact from this proposal.

Oversight assumes that since it is unknown if any businesses would qualify for the preference allowed by this proposal, that any impact of this proposal can be absorbed with existing resources.

Officials from the **Office of the Secretary of State (SOS)** state many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$2,500. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Oversight assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
