## FISCAL ANALYSIS

### ASSUMPTION

Officials at the **Kansas City Board of Election Commission, Missouri Ethics Commission, Office of the Secretary of State, Platte County Board of Election Commission** and the **St. Louis County Board of Election Commission** assume there is no fiscal impact from this proposal.

**Oversight** assumes this proposal would also require the Office of the Secretary of State to publish a notice for the August 7, 2012 election. The notice is estimated to cost more than \$100,000 and would be published in FY 2012.

Officials at the following board of election commissions: St. Louis City Board of Election Commission, Clay County Board of Election Commission and the Jackson County Board of Election Commission did not respond to **Oversight's** request for fiscal impact.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
