FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Health and Senior Services** state this proposal has no fiscal impact on their agency.

Officials from the **Department of Elementary and Secondary Education** assume the fiscal impact is minimal, if any, as most of the rights outlined in the resolution are implemented through the Individuals with Disabilities Education Act and other federal requirements.

Officials from the **Special School District of St Louis County** state they provide a full range of services to deaf and hearing impaired students and they do not anticipate that there would be a material fiscal impact on their district.

Officials from the **Parkway School District** anticipate no fiscal impact.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
