### ASSUMPTION

Officials at the **Office of Administration** defer to the Department of Labor and Industrial Relations for fiscal impact.

Officials at the **Department of Labor and Industrial Relations** assume there is no fiscal impact from this proposal.

Officials at the **Missouri Housing Development Commission** assume no fiscal impact to their agency. However, they are bound by federal government rules, when using certain federal program funds, which may require any development accessing federal funds to pay prevailing wage.
