Bill Summary: This proposal requires the legislative session to end in late March rather than mid-May beginning with the 99th General Assembly in 2017.

FISCAL ANALYSIS

ASSUMPTION

Officials from the **Governor's Office** assume there should be no added cost to their office as a result of this measure.

Officials from the **Office of Administration** assume the proposal will have no fiscal impact on their organization.

Officials from the **Missouri House of Representatives (MHR)** estimate the impact of the legislation will first be realized in FY 2017, which is beyond the scope of the fiscal note. Estimated annual savings in today's dollar is approximately \$700,000.

Oversight assumes the savings to the MHR from this proposal is beyond the scope of the fiscal note and therefore the savings will not be reflected.

Officials from the **Missouri Senate (SEN)** estimate the impact of the legislation will first be realized in FY 2017, which is beyond the scope of the fiscal note. Estimated annual savings in today's dollar is approximately \$161,506.

Calculations include related costs for attending session based on rates for current per diem and mileage. Estimate also includes salaries based on reductions in per diem, mileage, and session chamber staff cost based on fewer legislative days. These estimates do not consider any additional cost from Senators attending committee hearings on non-session days or for special sessions.

Oversight assumes the savings to the SEN from this proposal is beyond the scope of the fiscal note and therefore the savings will not be reflected.

ASSUMPTION (continued)

Each year, a number of joint resolutions that would refer to a vote of the people a constitutional amendment and bills that would refer to a vote of the people the statutory issue in the legislation may be considered by the General Assembly.

Officials from the **Office of the Secretary of State** assume unless a special election is called for the purpose, Joint Resolutions proposing a constitutional amendment are submitted to a vote of the people at the next general election. Article XII section 2(b) of the Missouri Constitution authorizes the governor to order a special election for constitutional amendments referred to the people. If a special election is called to submit a Joint Resolution to a vote of the people, section 115.063.2, RSMo, requires the state to pay the costs. The cost of the special election has been estimated to be \$7.1 million based on the cost of the 2012 Presidential Preference Primary. This figure was determined through analyzing and totaling expense reports from the 2012 Presidential Preference Primary received from local election authorities.

The Secretary of State's Office is required to pay for publishing in local newspapers the full text of each statewide ballot measure as directed by Article XII, Section 2(b) of the Missouri Constitution and Section 116.230-116.290, RSMo. The Secretary of State's Office is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. Funding for this item is adjusted each year depending upon the election cycle with \$1.3 million historically appropriated in odd numbered fiscal years and \$100,000 appropriated in even numbered fiscal years to meet these requirements. The appropriation has historically been an estimated appropriation because the final cost is dependent upon the number of ballot measures approved by the General Assembly and the initiative petitions certified for the ballot. In FY 2013, at the August and November elections, there were 5 statewide Constitutional Amendments or ballot propositions that cost \$2.17 million to publish (an average of \$434,000 per issue). Therefore, the Secretary of State's Office assumes, for the purposes of this fiscal note, that it should have the full appropriation authority it needs to meet the publishing requirements. However, because these requirements are mandatory, we reserve the right to request funding to meet the cost of our publishing requirements if the Governor and the General Assembly change the amount or eliminate the estimated nature of our appropriation.

Oversight has reflected in this fiscal note, the state potentially reimbursing local political subdivisions the cost of having this joint resolution voted on during a special election in fiscal year 2014. This reflects the decision made by the Joint Committee on Legislative Research, that the potential cost of elections should be reflected in the fiscal note. The next scheduled general election is in November 2014 (FY 2015).

ASSUMPTION (continued)

It is assumed the subject within this proposal could be on that ballot; however, it could also be on a special election called for by the Governor. Therefore, Oversight will reflect a potential election cost reimbursement to local political subdivisions in FY 2014.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

Upon voter approval, the proposed constitutional amendment would require the legislative session to end in late March rather than the middle of May. The veto session is moved from September to June. These changes to the legislative process would begin with the 99th General Assembly, which starts in 2017.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
