FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of Prosecution Services (OPS)** assume the proposal will have no measurable fiscal impact on the OPS. The creation of a new crime creates additional responsibilities for county prosecutors which may, in turn, result in additional costs, which are difficult to determine.

Oversight assumes the potential responsibilities imposed on county prosecutors as a result of this proposal, will be absorbable within current funding and staffing levels.

Officials from the **Office of Attorney General** assume any potential costs arising from this proposal can be absorbed with existing resources.

Officials from the **Department of Agriculture**, the **Office of State Courts Administrator** and the **Department of Health and Senior Services** each assume the proposal would not fiscally impact their respective agencies.

FISCAL IMPACT - Small Business

The proposal could impact small businesses making, processing, or selling kosher foods as certain foods offered for sale as kosher or kosher for Passover will have to have a label or symbol affixed identifying who certified the product.
