## FISCAL ANALYSIS

### ASSUMPTION

Due to time constraints, **Oversight** is referring to the earlier version of this proposal for agency responses:

Officials from the **Office of State Courts Administrator**, the **Department of Health and Senior Services** and the **Department of Social Services** each assume the proposal would not fiscally impact their respective agencies.

### Amendment No. 1

Due to time constraints, **Oversight** is using agencies' responses from similar legislation (HB 1103) from the current session:

Officials from the **City of Columbia** state the proposal does not appear to require the City to provide any more or less protection to the speech or religious practice rights of alternatives-to-abortion agencies. The proposal does not appear to prevent the City from addressing public health and safety issues associated with building code enforcement. Therefore, a fiscal impact is not expected.

Officials from the **Office of Administration**, the **Office of State Courts Administrator**, the **Department of Health and Senior Services**, the **City of Kansas City**, and **St. Louis County** each assume the proposal would not fiscally impact their respective agencies.

Officials from the **Office of Attorney General** did not respond to **Oversight's** request for a statement of fiscal impact.
