ASSUMPTION

Officials at the **Office of the State Courts Administrator (CTS)** assume this proposal would not be in excess of \$100,000.

Oversight assumes that any costs from CTS relating to this proposal could be absorbed within their current appropriation level.

Officials at the **Office of the State Public Defender** and the **Office of Prosecution Services** each assume no fiscal impact to their respective agencies from this proposal.

Officials at **St. Louis County, Cole County, the City of Kansas City, the City of Jefferson** and the **City of Columbia** each assume no fiscal impact to their respective organizations from this proposal.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
