## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Revenue**, the **Department of Higher Education**, the **Office of Attorney General**, the **Department of Insurance, Finance and Professional Registration**, the **Office of State Courts Administrator**, and the **Joint Committee on Administrative Rules** each state this proposal will have no direct fiscal impact on their respective agencies.

In response to a previous version of this bill, officials from the **Office of Secretary of State (SOS)** stated many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS's office is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to Secretary of State's office for Administrative Rules is less than \$2,500. SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what their office can sustain with their core budget. Therefore, SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

**Oversight** assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal with core funding. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process.

Officials from **Linn State Technical College** state this proposal will have no fiscal impact.

In response to the introduced version of the proposal, the following colleges and universities assumed no direct fiscal impact on their respective institutions: **Lincoln University**, **Northwest Missouri State University**, **University of Missouri System**, **Missouri Western State University**, **University of Central Missouri**, and **Missouri Southern State University**

FISCAL DESCRIPTION


The proposed legislation appears to have no direct fiscal impact.
