This proposal would require, at the written request of birth parents, that all birth records of a child remain confidential. These records may be disclosed, under certain conditions, to the following: government agencies; researchers; insurers; and any persons with written consent of the individuals to whom the information pertains. The proposal has a penalty provision.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
